REVISED NEW YORK STATE UNIFORM FIRE AND BUILDING CODE**

WHEREAS, the State of New York has amended certain provisions of the New York State Uniform Fire and Building Code, which provisions are required to be administered and enforced by local municipalities throughout New York State; and

WHEREAS, the Town Board of the Town of Wallkill held a public hearing concerning the adoption of a local law amending the Town Code of the Town of Wallkill to comply with revised administration and enforcement provisions of the New York State Uniform

Fire and Building Code on December 27, 2006 at 7:25 p.m. at the Town of Wallkill Town Hall, 99 Tower Drive - Building A, Middletown, New York; and

WHEREAS, all parties in attendance at said public hearing were permitted an opportunity to speak on behalf of or in opposition to said proposed local law; and

WHEREAS, the Town Board of the Town of Wallkill, after due deliberation, finds it in the best interests of said Town to adopt the proposed local law in order to comply with revised administration and enforcement provisions of the New York State Uniform Fire and Building Code;

NOW, THEREFORE, BE IT HEREBY
